

## **Notes from the Chair**

I am very excited to be your Chapter Chair. First, I'd like to thank John Bramble for his leadership this past year and to all of the appointed officials, committee chairs, and committee members. Your work is appreciated and essential to MCMLA.

Speaking of committees, thank you to all who volunteered to join a committee. You will learn so much about the organization and your contribution will help it move forward. There are still two openings on the Membership Committee. If you are interested, please email me!

I'd also like to celebrate and thank the planning group for the 2018 virtual meeting. They did a great job putting the meeting together. Virtual meetings are quite a feat! Kudos as well to all of the presenters who informed and enriched us.

I'd like to share with everyone my priorities, which were presented at the virtual meeting. I've been told it's ambitious, but I'm confident we'll make significant progress during my time as chair and I will continue to work on these initiatives in my future role as Immediate Past Chair.

## Priority 1: Strategic Plan

#### Tasks:

- Communicate committee strategic goals to the membership
- Communicate progress through the year of goals to the membership
- Establish a strategic plan website which will reflect completed goals

My first priority should not be a surprise. A strategic plan was developed and committee goals were based on the plan this past year. Goals will continue to be developed utilizing the strategic plan as a framework moving forward, and I will assist the committees in their creation. It is my intention to communicate these goals to the membership once they are established in the beginning of the MCMLA year. Updates will be provided during the year as well as at the next annual business meeting in 2019. A website will be created to reflect the goals that have been accomplished, so that the information is easily accessible to committees and the membership at large.



**Priority 2: Committee Assessment** 

#### Tasks

- Assess roles of committees as they relate to member expectations
- Work with committees to determine any changes to roles
- Work with committees to determine ideal number of members

During the 2014-15 MCMLA year, Jackie Hittner, as chair, assessed committee roles. It is time again to look at these and that will be my second priority.

Our committees need to be a reflection of our membership and their needs. Times do change, even over the course of four years, and since our last assessment we have seen a 9% decrease in overall membership (which includes students and emeritus members), and a 15% decrease in regular membership. Some of that is due to retirements, but this is our biggest drop since the one experienced in 2014.

What does that have to do with committees? Fewer members mean fewer individuals available to serve. Do the required numbers for committee members make sense? Do they need more? Do they need less? What do the committees do? Have membership needs changed? Has the role of the committee changed? We need to reassess our committee structure and make adjustments where necessary. The final question is, do we need all of the committees? Can any be merged? Have any run their course? It will not be an easy assessment and it will take time. I assure you that all of those involved will be very thoughtful throughout the process and the membership will be kept informed.

# Notes from the Chair (cont'd)

#### **Priority 3: Assess Engagement**

**Tasks** 

- Create Engagement Task Force, charged to
  - Create and disseminate a survey to the membership, and
  - Make recommendations to the Executive Committee

For the third priority, I return to the time I spent talking with committee chairs and potential committee member recruits. I came out of those conversations believing that member engagement needs to be assessed. All organizations go through this and I feel that with decreasing membership, this is critical.

We need to ask: What are we doing right, what are we doing wrong, and what are we not doing? Why do people want to remain with MCMLA? What would they like to see from MCMLA? Why don't they volunteer for committees?

I realize there is a lot of overlap between these priorities and that one influences the other. My intention is to plot a strategy so that these changes are made in the most efficient manner possible.

And then there is that dreaded, scary word: "assessment." You're probably thinking to yourself, that that means a survey! And you would be correct. Your voice is very important to the future of MCMLA, so when you see a survey, please respond. Your opinions matter.

Thank you for the privilege of serving as your Chapter Chair. I look forward to engaging with you and making this a great year for MCMLA.

## 2018 MCMLA Meeting Recap

The 2018 MCMLA virtual meeting - *Partners in Progress – Exploring the Possibilities* - was a huge success! A total of 116 people attended the two-day conference held October 4 -5, 2018.

#### Meeting highlights include:

- Jessi Van Der Volgen and Molly Knapp from the National Network of Libraries of Medicine Training Office co-taught the free continuing education class, "Teaching Topics: Assessment on the Fly."
- Sally Gore, MS, MSLIS, gave the first keynote presentation, "Picture This: A Visual Story of the Building Partnerships." Gore is the Manager of Research and Scholarly Communication Services for the Lamar Soutter Library, University of Massachusetts Medical School. She oversees the Library's efforts at collaboration with basic science and clinical researchers on campus as well as all scholarly communication endeavors, including eScholarship@UMMS (Institutional Repository).



- Dr. Katalin Gothard, a Professor in the departments of Physiology and Neuroscience at the University of Arizona Health Sciences, College of Medicine in Tucson, gave the second keynote speech. Dr. Gothard spoke about how she communicates the importance of animals in research and what's important for animal researchers to keep in mind as they proactively communicate their work to a variety of audiences.
- Nine 5-minute lightning talks were offered
- Three 20-minute papers presentations were held.
- Vendors included: Ebsco, CyberTools, Matthews, Rittenhouse and Wolters Kluwer.
- The MCR RML gave their annual update.
- Kathi Canese, PubMed Project Manager of the National Library of Medicine, provided an update on PubMed.
- The annual MLA Update was given by Beverly Murphy, President of the Medical Library Association.







## 2019 MCMLA Membership Renewal

## **Grant Opportunities**

# The MLA Research, Development, and Demonstration Project Grant

The Medical Library Association (MLA) is now accepting applications for the MLA Research, Development, and Demonstration Project Grant.

The purpose of this grant is to provide support for research, development, or demonstration projects that will help to promote excellence in the field of health sciences librarianship and information sciences. Grants range from \$100 to \$1,000. Grants will not be given to support an activity that is operational in nature or has only local usefulness. More than one award may be granted in a year.

### Eligibility

- The applicant must hold a graduate degree in library science.
- The applicant must be a practicing health sciences librarian with at least two years of professional experience.
- The applicant must be a citizen of or have permanent residence status in either the United States or Canada.
- The applicant must be a member of the Medical Library Association (MLA).
- In the case of a research group, at least one person in group must be a MLA member and meet the above criteria.
- Consideration will be given in exceptional cases to an outstanding candidate not meeting the criteria above.

#### Terms

- The completed application form must be received by December 1.
- The applicant must submit the names of two references not related to the applicant/group. The references must be persons who are knowledgeable about the applicant/group's character, education, and abilities.
- The scope and nature of the proposed project should give evidence of an established methodology and a viable research design.
- The application should show how the proposed project would contribute conceptually and practically to the applicant/group's competence and the well being of the library community.
- The proposal should contain title, goals, objectives, methodology, significance, and budget of project; vital and special qualifications of the research;

knowledge of the state of the art and existing published literature on the proposed research topic; and proposed means of disseminating the results.

• The applicant may upload a current photo to member profile for promotional purposes (optional).

The following criteria will be used to evaluate the applications:

### Applicant/Group:

- education and training
- experience
- research competence
- · adequacy of knowledge of research field
- research potential
- previous productivity

## Proposed projects:

- relevancy to the association's purpose
- originality
- importance to the profession
- soundness of experimental design and detail
- feasibility of scope
- Grantees are expected to submit a copy of the final report of their research to MLA with the understanding that MLA has the "first right of review" for publication. If the report is not accepted by MLA and is subsequently published by another publisher, recognition of association support must be given.
- More than one grant may be offered in a year. Grants range from \$100 to \$1,000 and are paid in a single payment.
- The period of disbursement will not exceed one year past the date of the MLA annual meeting.
- Depending on the qualifications of the candidates, the jury may recommend that awards not be presented in a given year.
- MLA will acknowledge applications upon receipt via email

Joining the Academy of Health Information Professionals (AHIP) has never been easier. A new system has been launched allowing you to download fill-in AHIP forms, upload or email the completed portfolio, and pay online.

**New Job Requirements:** Because of the economic recession, some medical librarians are no longer full-time medical librarians, have left the field, or have become a different type of librarian. MLA realizes there are librarians who want to move into, remain in, and come back to the health sciences librarian field and want AHIP membership. To help members succeed with AHIP, the MLA Board of Directors has approved changes to the job requirements for AHIP starting May 1, 2012. **Provisional Membership:** Starting January 1, 2014, all provisional membership applications (both new and renewing) will be required to include 5 points of professional individual accomplishments per year. This new requirement will allow members the opportunity to become more involved with MLA; MLA Sections, SIGs, and Chapters; and local medical library groups. Professional individual accomplishments then can be used towards the application for membership when the provisional member moves on to the member or senior level of AHIP.

Currently there are roughly 1100 AHIP members who participate in the academy at 5 levels of membership. Why don't you join us?
